**ORDINANCE NO. 06-S.2009
(SPONSOR: HON. JOELITO G. INTONG)**

AN ORDINANCE TOTALLY BANNING ALL TYPES OF MOTOR VEHICLES WITHOUT MUFFLER, WITH CUT OR DISCONNECTED SILENCER ANYWHERE IN THE MUNICIPALITY OF CALAMBA

Be it ordained by the Sangguniang Bayan of Calamba, Misamis Occidental in its Regular Session assembled that;

SECTION 1. Prohibited Act. Motor vehicles without muffler, with cut or disconnected silencer banned anywhere in the municipality of Calamba.

SECTION 2. Definition of Terms.

- a. Motor vehicles – as used in this ordinance shall mean those motorized or powered by an engine with assigned plate number as reflected in its official registration certificate.
- b. Muffler/Silencer – is an instrument or part of the motor vehicle that reduces its sound when the engine starts.

SECTION 3. Administrative Provision:

- a. Violators of this Ordinance will be apprehended and issued with a citation tickets with the corresponding fines. Payment of the fines shall be at the Municipal Treasurers Office or through its authorized representative within 72 hours from its issuance.
- b. Subject vehicles of apprehended violators shall be turned over to the LTO for proper disposal and shall only be released upon presentation of the Official Receipt as evidenced in the payment of fines and Registration Certificate as proof of ownership after fixing the cut or disconnected muffler.
- c. Vehicles of apprehended violators without drivers license and registration certificate shall be released only upon presentation of his/her drivers license and registration as proof of ownership.

- d. The LTO shall be furnished copy of this Ordinance for their information, guidance and appropriate action.
- e. The Local Traffic Personnel in coordination with the PNP Traffic Enforcer and the Roadsters shall strictly implement this Ordinance.

SECTION 4. Penalty – Violators of this Ordinance shall pay a fine of Five Hundred Pesos (P500.00) to be paid to the Municipal Treasurer's Office or suffer an imprisonment of five (5) days or both at the discretion of the court.

SECTION 5. Repealing Clause – Any existing Municipal Ordinance, Resolutions and Regulations or parts hereof inconsistent with any provision of the Ordinance are hereby repealed/amended.

SECTION 6. Separability Clause – If for any reasons, any part of provision of this Ordinance is declared unconstitutional or invalid, other parts or provision hereof which are not affected shall continue to be in full force and effect.

SECTION 7. Effectivity. This Ordinance shall take effect upon its approval.
