ORDINANCE NO. 17-s.2020

AN ORDINANCE AMENDING SECTION 5. PENALTIES OF ORDINANCE NO. 11-S.2020 "DIRECTING THE MANDATORY WEARING OF ANY PROTECTIVE MASK(S) THAT COVERS THE NOSE AND MOUTH IN PUBLIC AS PROTECTIVE MEASURE(S) TO PREVENT THE SPREAD OF COVID-19".

PREFATORY STATEMENT

WHEREAS, the Department of Health has defined and operationalized minimum public health standards as a set of guidelines, strategies, and or other non-pharmaceutical interventions (NPIs) intended and suppress the transmission of COVID-19;

WHEREAS, pursuant to existing guidelines by the national government subject to fair and human penalties or punishments that may be imposed by LGUs or implemented by law enforcement agencies, respectively;

WHEREAS, in view thereof, all local government units are hereby directed to implement existing national laws and/or enact/amend local ordinances that shall ensure the compliance with the aforesaid Omnibus Guidelines and minimum public health standards prescribed by the DOH within their respective jurisdiction.

NOW THEREFORE, on motion of Hon. Emmanuel M. Cale duly seconded by all members present;

BE IT ORDAINED, by the Sangguniang Bayan of Calamba, Misamis Occidental in its session assembled that:

SECTION 1. TITLE: This Ordinance shall be known as "AN ORDINANCE AMENDING SECTION 5. PENALTIES OF ORDINANCE NO. 11-S.2020 "DIRECTING THE MANDATORY WEARING OF ANY PROTECTIVE MASK(S) THAT COVERS THE NOSE AND MOUTH IN PUBLIC AS PROTECTIVE MEASURE(S) TO PREVENT THE SPREAD OF COVID-19".

Section 2. AMENDMENTS: Section 5. Penalties of Ordinance No. 11-s.2020 is hereby amended to wit:

- First Offense** - a fine of P1,000.00 and/or imprisonment for 10-30 days at the discretion of the court;
- Second Offense** - a fine of P1,500.00 and/or imprisonment for 10-30 days at the discretion of the court;
- Third Offense** - a fine of P2,500.00 and/or imprisonment for 10-30 days at the discretion of the court;

SECTION 3. REPEALING CLAUSE. All ordinances, resolutions or laws of local application and effect inconsistent hereto are hereby modified, suspended or repealed accordingly.

SECTION 4. SEPARATELY CLAUSE. If for any reason or reasons, any part of the provision thereof shall be held unconstitutional or invalid other parts or provisions hereof which are not affected hereby shall constitute to be in full force and effect.

SECTION 5. EFFECTIVITY. This ordinance shall take effect upon approval by higher authorities concern.
