RESOLUTION INTEGRATING THE DISASTER RISK REDUCTION MANAGEMENT FUND TO THE ANNUAL INVESTMENT PLAN FOR CALENDAR YEAR 2020 OF THE MUNICIPALITY OF CALAMBA, MISAMIS OCCIDENTAL.

WHEREAS, Section 21 of Republic Act 10121 provides that the LDRRMF amounting to not less than five percent (5%) of the estimated revenue from regular sources shall be set aside to support disaster management activities;

WHEREAS, DRRM activities such as pre disaster preparedness programs including training, purchase of rescue equipment, supplies and medicines, for reconstruction projects and payment of premiums on calamity insurance;

WHEREAS, the LDRRMF shall cover the Thirty Percent (30%) Lump Sum Allocation for Quick Response Fund (QRF) and the Seventy Percent (70%) Allocation for Prevention and Mitigation, Preparedness Response, Rehabilitation and Recovery;

WHEREAS, the DRRM budget for 2020 are as follows:
