WHEREAS, the Municipality of Calamba is requesting the National Heritage Commission (NHC) to declare the involves area as Heritage District Zone;

WHEREAS, the significant structures of buildings or houses involved like the Liberation Institute, Calamba Central School, Dayongco; Migrino and Rizal Rotunda were built century old;

WHEREAS, the said structures embrace the historical view of Calamba;

WHEREAS, an emergency notice thru resolution requesting the NHC to take immediate action regarding the application for Heritage Zone;

APPROVED, this 2nd day of December, 2019 at Calamba, Misamis Occidental.


