RESOLUTION REQUESTING ENGR. OMAN P. DIRON, DISTRICT ENGINEER, 1ST ENGINEERING DISTRICT, PROVINCE OF MISAMIS OCCIDENTAL TO ACCOMMODATE THE PLACING OF ADDITIONAL PEDESTRIAN LANE WITHIN THE MUNICIPAL STREETS/ROADS OF THE MUNICIPALITY OF CALAMBA, MISAMIS OCCIDENTAL.

14. Mormon's Church
15. Kateleen Apartelle
16. Shell Gasoline Station
17. Angel's Pharmacy

APPROVED, this 20th day of January 2020 at Calamba, Misamis Occidental.


