RESOLUTION APPROVING THE CONVERSION OF BUNAWAN ELEMENTARY SCHOOL TO BUNAWAN INTEGRATED SCHOOL IN BARANGAY BUNAWAN, CALAMBA, MISAMIS OCCIDENTAL.

WHEREAS, Bunawan Elementary School situated at Bunawan, Calamba, Misamis Occidental aims for the conversion to Bunawan Integrated School, to give accessible and quality education to high students considering that there is no secondary school within the catchment area and as well as to the elementary pupils who cannot afford to go to private schools in town;

WHEREAS, the honorable Barangay Council of Bunawan, and the Parent-Teachers Association of Bunawan Elementary School, passed Joint Resolution No. 04-2020, dated January 6, 2020, requesting the Department Education to convert Bunawan Elementary School into an integrated school and to provide the funds for the construction of classroom buildings;

WHEREAS, this Sanggunian strongly believes that the intentions of the Bunawan Barangay Council and Bunawan Elementary School PTA are noble and responsive to existing needs in the community.


WHEREAS, on motion of Hon. Cherry F. Magsayo and duly seconded by all the members present;

NOW THEREFORE ON JOINT SPONSORSHIP, Be it resolved by the Sangguniang Bayan of Calamba, Misamis Occidental as it is hereby resolved to approve the Conversion of Bunawan Elementary School to Bunawan Integrated School in Barangay Bunawan, Calamba, Misamis Occidental.
