RESOLUTION REQUESTING THE GOVERNMENT INSURANCE SYSTEM (GSIS), THROUGH ITS DIPOLOG CITY BRANCH OFFICE, FOR THE INSTALLATION OF GWAPS KIOSK IN THE MUNICIPALITY OF CALAMBA, MISAMIS OCCIDENTAL.

WHEREAS, in its continuing goal of bringing its services closer to their members and pensioners, GSIS introduced GWAPS Kiosk which offered convenience in applying for a loan, checking their records, and updating their information without the need to go to GSIS Offices;

WHEREAS, the Municipality of Calamba is situated 40 kilometers away from Oroquieta City where the nearest GWAPS is located:

WHEREAS, the GWAPS Kiosk once installed in this municipality could cater at least 1,500 active members and pensioners from within and the neighboring municipalities of Baliangao, Sapang Dalaga, Concepcion and Plaridel;

WHEREAS, on motion of Hon. Cherry F. Magasayo and duly seconded by all the members present;
