RESOLUTION APPROVING THE REVISED COMPREHENSIVE CHILDREN'S WELFARE CODE OF CALAMBA, MISAMIS OCCIDENTAL BASED ON ORDINANCE NO. 1-S- 2016 – AN ORDINANCE ENACTING THE COMPREHENSIVE CHILDREN'S WELFARE CODE OF CALAMBA, MISAMIS OCCIDENTAL, APPROPRIATING FUNDS THEREFORE, PROVIDING PENALTIES AND FOR OTHER PURPOSES.

WHEREAS, Calamba, Misamis Occidental thru the Local Council for the Protection of Children (LCPC) has formulated the Comprehensive Children's Welfare Code in 2016;

WHEREAS, an Ordinance No. 1-s-2016 enacting the Comprehensive Children's Welfare Code of Calamba, Misamis Occidental was passed by the Sangguniang Bayan;

WHEREAS, the Local Council for the Protection of Children (LCPC) reviewed and recommended the revision of the Local Code for Children since the said ordinance is already six years of its implementation;

WHEREAS, there are current laws and policies for children program passed by the government;

WHEREFORE, on these premises and on motion of Hon. Caridad C. Lansang and duly seconded by all the members present, **BE IT**;


